Walid Rouis appointed Deputy Chief Executive of **ACTIA Group**



On 16 December 2024, the Board of Directors of ACTIA Group, on a proposal made by the Chief Executive Officer, appointed Walid Rouis to the position of Deputy Chief Executive in charge of operations. He will take up his post on 1 January 2025.

For Jean-Louis Pech, Chairman and CEO of ACTIA Group: "The appointment of Walid Rouis is part of the drive to strengthen the Group's governance. It comes at a time when there are as many opportunities as there are challenges". Walid Rouis will thus join the other Deputy Chief Executives of ACTIA Group, namely Catherine Mallet, in charge of Finance and Communications, Jean-François Calmels in charge of Corporate Social Responsibility and Marine Candelon in charge legal and administrative affairs.

Walid Rouis has been working for ACTIA Group for almost 18 years. Graduating as an engineer from ENSEIRB (Bordeaux INP or Institute of Technology) in 2002, he began his career as Project Manager in the field of embedded electronics and joined ACTIA Group in 2007. In 2011, he became General Manager of ACTIA Engineering Services, the research and development centre known for its work in the area of electronics and software architectures, which became one of ACTIA's new divisions this year. In 2018, he created ACTIA Africa, the Group's business entity on the African continent, of which he is the Chief Executive. A man of action, committed to ACTIA's values, and whose technological and industrial goals he also shares, Walid Rouis will take up his post on 1 January 2025. He will also continue to assume his responsibilities as the head of ACTIA Engineering Services and ACTIA Africa for a transition period.

This appointment is one of the first steps in the plan to strengthen the Group's governance approved by the Board of Directors on 16 December 2024. In effect, the term of office of Jean-Louis Pech as Chairman and Chief Executive Officer will end at latest by 19 December 2025, in accordance with the statutory provisions regarding age limits. At a Board meeting to be held towards the end of 2025, there will be a vote to separate the functions of Chairman of the Board of Directors and Chief Executive Officer of ACTIA Group and to appoint Walid Rouis as Chief Executive Officer of ACTIA Group, while Jean-Louis Pech will continue to be Chairman of the Board of Directors of ACTIA Group.
